

# GREATER MIAMI AND THE BEACHES OPEN FOR BUSINESS



## HOTELS

- Staff must wear facial coverings when in interior and exterior common areas.
- Guests must wear facial coverings when in interior common areas and when social distancing cannot be achieved in outdoor common areas.
- Hotel Pools: Facial coverings are not required when swimming; facial coverings are to be worn on the deck areas when social distancing is not possible.
- Minimize shared touch surfaces such as kiosks, tablets, pens, credit cards, receipts and keys.
- Guest room service, laundry and dry-cleaning services, and amenity deliveries should be made available using contactless pick-up and delivery protocols.
- Remove or limit paper amenities in guest rooms
- Valets should use sanitizer before and after parking vehicles.



## BEACHES, PARKS & OUTDOOR RECREATIONS

- Facial coverings shall be worn when in public, except when engaging in activities that are strenuous or get your mask wet.
- Group size shall not exceed the capacity to safely accomplish six feet social distancing at any time.
- The following are open/allowed, with social distancing policies (facial coverings, hand hygiene, six feet of social distancing) in place:
  - » Playgrounds, picnic and shelter areas, canopies and tents
  - » Fitness courts and practice facilities
  - » Competitions, individual and team instruction, organized group activities, athletics
  - » Clubhouses, locker rooms, golf carts (limited to two riders)
  - » Food and beverage operations
  - » Fishing



## RESTAURANTS, CLUBS & BARS

- Restaurants are offering indoor and outdoor dining at up to 100% capacity so long as they can maintain six feet of distance between groups.
- In most restaurants a QR code is available to view menus digitally, and touchless payment options may be available.
- Curbside takeout, delivery or drive-through options are available at most Greater Miami restaurants.



## MEETING & CONVENTION SPACES

- All event attendees shall wear facial coverings while on the premises.
- All venues shall establish staggered entry times to minimize overlap and congregating of patrons at checkpoints (i.e., access points, security checkpoints, admission areas, turnstiles, concession areas).
- For venues hosting multiple events, there should be established staggered event times to minimize patrons from different events congregating with one another.
- Defined seating areas will be used to maintain physical distancing of at least six feet between members of different groups.



## ENTERTAINMENT VENUES, INDOOR ATTRACTIONS & MUSEUMS

- Movie theaters, concert houses, auditoriums, bowling alleys, arcades, museums, indoor amusement facilities and casinos are open.
- Consumers must abide by health and safety requirements including use of facial coverings and social distancing.
- Indoor food and beverage consumption and live performances are allowed, with restrictions.
- Facial coverings must be worn upon entering but can be removed while eating and drinking.
- Aisle seats and space around aisles and pathways will be open to ensure proper social distancing.
- App-based ordering may be available to minimize patrons having to wait in line, linger and congregate in concession and merchandise areas.



## MALLS & RETAIL SHOPS

- Facial coverings must be worn inside retail establishments.
- Entry and exit points are indicated by markers creating one-way circulation paths inside stores.
- Home delivery, curbside pickup or limited "appointment only shopping" for customers is encouraged.
- Retailers may allow single-use sampling of personal goods (makeup, perfume, lotion) or use touchless options.
- Special store hours for seniors and vulnerable guests may be considered.
- Steaming to sanitize items that have been tried on or returned by customers is encouraged.



PARTNERS IN HOSPITALITY

Facial coverings are required when indoors. Children 2 years old and under do not need to wear a facial covering.
